### Protection of personal information

### Destruction of personal identity documents

The copy of any ID is destroyed in compliance with the Act respecting Access to documents held by public bodies and the Protection of personal information (chapter A-2.1) and the Archives Act (chapter A-21.1), following the issue of a licence, the refusal to issue a licence (final decision), the abandon of the licence application or if the application is returned to the sender because it is incomplete. Any invalid ID will be destroyed upon its receipt.

If your application is incomplete, we will contact you in writing. You will then have a 21-day deadline to send us the missing documents or information to process your request.
